**APPLICANT'S CERTIFICATION:** By applying for utility service, I agree to abide by the City's utility system ordinances. Any bill not paid in full within 30 days will accrue interest at 1.5% per month (18% per annum). If collection action is necessary to collect unpaid utility charges, I agree to pay all collection expenses, including all fees charged by the collection agency, as well as the City's reasonable attorney fees incurred at trial and on appeal. City utility service will be shut off if a bill is not paid within 60 days. At any time, the City may place a lien against the real property for unpaid utility bills, plus interest at 1.5% per month (18% per annum).

**RETURN OF DEPOSIT:** Your deposit is refundable after one year's good credit, and can be either applied to your bill or refunded to you by check, at your option. If you terminate utility service before the end of one year, the deposit will be applied to any bill owing when you leave, and the balance (if any) refunded.
